If your backflow did NOT pass this test, you should have been informed and you need to get it repaired and tested ASAP as a faulty backflow device could cause contamination into our water supply which is not good. Nine homeowners were sent a letter on October 19th that their backflow did not pass last year's

test and they need to fix that ASAP and get it tested as well and they have 30 days to get that taken care of or they risk having their water turned off. - The monthly Board meeting has a new time. It is still every second Thursday, but the time is now 4:00. Be sure to contact one of the Board members prior to the meeting if you wish to attend.
- Water meters will have been read for a final time on November 1st and will not be read again until April 1, 2024. Please be sure to winterize any outside faucets and sprinkler systems to hopefully avoid freezing and breaking or leaking of water lines. Your water bill for those months when the meters are not read will be the standard \$50.00 plus any balance that has not been paid from a prior bill. Unfortunately, when the meters are read in April each year, that is when leaks show up and your water bill is higher than the \$50.00. You are responsible for your water lines once the water passes through the meter. Each year some people find a broken line that unfortunately ran water continuously for some time, and their bill is surprisingly much higher than anticipated.
- The limb cutting and clearing at the office is nearly completed and looks much more fire safe, and we send a big thank you out to the Dendy's with their volunteers, the McLean's, Deb Leslie, Lil Cross, and Terry Smith. This is a great time of the year now since the growing season is over to do some outside clean up of brush piles and plants and useless junk on your property. We recently received a couple of complaints about a neighbor's unsightly property that needs to be cleaned up. We are all proud to live in this great community. We don't want it to turn into a garbage dump!


