- We have a schedule to **seal the cracks on the roads**, the last week of August. If you want to get a quote to seal your driveway call Tri County Paving 541-526-5800.
- Wildfire Season. We hope you all have read and saved the foldout we recently mailed to everyone to help you prepare for this hot summer season we are having and to know what to do if a fire erupts within or threatens our HOA. The fires are everywhere in Oregon, and could happen here just as easily, so please, be prepared.
- Dogs again. More complaints of dogs running loose, so please keep your dog under control and leashed or fenced in. This seems to be a continuing problem with the same few dogs. We just had a report of a pedestrian getting bitten by two uncontrolled dogs on David Way. Law Enforcement may need to be involved in this one, if you love your pets, keep them under control at all times. You may face criminal or civil penalties if your pets injure another person or animal. Please be responsible for your pets.
- We have had a couple of property sales this summer, so please **welcome new HOA members** when you have a chance.
- At the annual HOA meeting in May, property owners approved a budget of \$35,000 for a **service/plow truck for the HOA**, we are pleased to announce that we have acquired that truck and the final cost will be somewhat over half of the approved budget. We are currently deciding where to park the truck for safety concerns, and are exploring costs to build a metal garage building with locking doors.
- An older white flatbed pickup truck was observed driving well in excess of **45mph** while under hard acceleration on at least two occasions recently, this kind of reckless disregard for the safety of HDE families and visitors will not be tolerated, any person operating a motor vehicle in such a manner, if identified as a resident of HDE, may lose their water privileges and/or be subject to any other fines or penalties as the Board sees fit.
- Every month on different days and at different locations, our water is tested. A couple weeks ago one of the samples tested E. coli in an outdoor faucet, not in a cistern or well. Subsequent tests by the Prineville water inspector showed the water had cleared. We hope to better communicate should this issue arise again.


