**UPCOMING BOARD MEETING** 

**November 13** 

Burris Plumbing has completed testing 138 backflows in our HOA and all but 3 tested perfectly, and the cost of the testing was \$8,280.00. There were three homes that failed and those homeowners will be getting a letter soon to let them know a repair or replacement needs done, then retested, and a copy of the letter from the testing agent showing their backflow now passes. The repair or replacement this year is at the homeowners expense, but the HOA will cover the cost next year for the 2026 testing. These backflow devices are a state mandated requirement in Oregon and need to be tested yearly for everyone's safety.

**TriCounty Paving has finished** their annual crack sealing project on those roads that needed it and we have yet to receive an invoice, but it was estimated at \$16,000.00. We also have had some culverts cleaned to prepare for winter, and the cost of that was \$1,800.00. A big thanks to Bill Huret, our road expert, for orchestrating and working on these two projects with the two companies.

**Abbas Pump Services** will be repairing our well #5 soon at a cost of \$5,500 for the 3 HP, 10 gallon per minute pump plus costs for the extra piping and wiring.

Your Board has signed the contract with *Blue Mountain Community Management* Company and have begun the transition process and plan on them assuming all the billing by December 1st, and responsibilities of paying vendors and bills associated with keeping our HOA as we have done since the beginning of the Association. We retain the existing Board of Directors who make decisions as they currently do and our Treasurer approves all expenditures for the new management Company to pay all the bills. You will be getting a "Welcome Letter" soon from Blue Mountain explaining how they do business for you. The increase on your dues will be reflected in your December billing, going from \$55.00 per month to \$75.00 which includes both water and dues.

Recently the Board established four new Resolutions and these are included in your bills this month, so please read them and let one of us know if you have any questions.
